21st Annual Denman Island Beach Cleanup

Our 21st Annual Beach Cleanup was held Oct 26th to Nov 2nd 2024 with 60-70 volunteers working on multiple teams doing beach and boat pickups, driving trucks and trailers, sorting and categorizing debris, and loading the container at the Old School field for transport to Ocean Legacy Foundation's marine debris collection hub in Cumberland. With the support of BC Shellfish Growers Association, Hornby Island Diving, CVRD, and Great Canadian Shoreline Cleanup, we collected 9 tons of marine debris this year! We noticed that some plastic oyster trays displayed ID numbers, a new requirement by DFO so that lost equipment can be traced back to the tenure owner. The new rules include better practices, more secure storage, and increased consequences; however, much more work is needed to obtain true industry accountability.

We decided to try something different with the Annual Beach Cleanup this year. We are going to move what had evolved into a Fall cleanup to the Spring instead. Please keep collecting marine debris, if you come across any on the beach, and move it to higher ground. Winter storms and king tides can wash it out to sea again, so this will help keep it out of the marine ecosystem until collection can take place by truck or boat in Spring 2026. Many thanks to the amazing residents who volunteer every year and a huge shout out to our partners who make this work possible!





Predator Netting in Estuaries

Great news! The following are direct quotes from the new 2025 Conditions of Licence for shellfish growers: "By May 1, 2027, licence holders shall not have intertidal equipment located within 50 metres of the nearest edge of an intertidal stream channel, including braided and seasonally flowing stream channels, which flow from, or connect to, a salmonid bearing stream." Additionally, "the licence holder shall not install equipment or gear, nor conduct activities, within important and sensitive habitat." ADIMS has lobbied for removing nets for 20 years, and here we've had real success! We can look forward to at least half of all netting being removed from Baynes Sound, though enforcement of the new requirements will be critical.

Predator Netting & Sea Birds

ADIMS is planning research with the support of the K'ómoks Important Bird Area Manager, birdwatchers, and a local shellfish processor, to trial growing clams with little or no netting. Netting and oyster grow-out currently cover about 60% of the foraging area for sea ducks. Shellfish growers cover clam beds with netting to stop sea ducks from eating their clams; however, those clam beds have been there for thousands of years and, for an equally long period, sea ducks, like surf scoters long-tailed ducks, overwintering in our area, and rely on those clams to build up energy reserves for their migration north and to raise their young.

Community Concerns & Complaints

We added a section to the ADIMS website that describes how to file complaints on various marine issues with the appropriate government agencies. We are hopeful that this will be helpful if you have a concern that requires attention. Overall, we have had fewer new complaints this year, but we are still working on several complex, long-standing complaints. The encroachment of aquaculture activity on sensitive marine areas is indeed quite complicated, so we will continue to work on this with the various government agencies involved. Thank you for your vigilance on behalf of the marine inhabitants. We're here to help!

Sea Star Wasting (SSW) Monitoring

This was our second year of SSW monitoring. Like last year, most of our observations were of healthy sea stars, but there is still evidence of SSW in an area on eastern Denman. Thanks to all who participated! We would love to increase our monitoring and include additional sites for spring/summer 2026, so please contact us if this interests you. The time requirement is not demanding and it's a great activity to do with kids! One interesting update on the science front is that researchers have finally pinpointed a strain of the bacterium Vibrio pectenicida as the cause of SSW, which has killed billions of sea stars between Alaska and Mexico since 2013. Researchers are now focusing on drivers of disease, and most notably, the link between ocean warming and SSW (Vibrio species thrive in warm water).

Predator Netting & Entanglements

ADIMS is planning a campaign against predator netting, and has been working with drone operators, divers, and videographers to produce media to inform the public and advocate for the removal of all netting. Thanks to DenmanWORKS! and the CVRD for their financial support. Though intended to protect clam beds from predators, many nets are loose and entangle fish, crabs, seals, birds, and even sea lions.

Ecosystem Forum

Directors met over the summer to do some long-term strategic planning. This November they will hold an Ecosystem Forum on the Beaufort Watershed and its connections to Baynes Sound. ADIMS has stepped down from the EcoForum's Board of Directors, but we will continue to attend gatherings and offer support.

Herring Conservation & Restoration

ADIMS continues to advocate for a pause in the commercial herring fishery. We are trying to broaden our alliances with groups that share the same urgency about the dire state of local herring stocks. This year, we joined the Board of the Herring Conservation and Restoration Society (HCRS), which is working closely with WSÁNEĆ Hereditary Chiefs. HCRS and ADIMS are supporting the WSÁNEĆ legal challenge to DFO's management of the herring fishery, which breaches WSÁNEĆ Douglas Treaty rights. HCRS sent a letter to the Minister of Fisheries and Oceans that you can read on our website under news. We are also planning several events for the new year, in collaboration Conservancy Hornby Island and HerringFest.

The feature film "Deep Rising" had stunning visuals and it raised important questions about the race to mine the deep seabed and the environmental consequences of disturbing this poorly understood ecosystem.




Shipbreaking Event & Update

On July 5th we received the good news from Concerned Citizens of Baynes Sound (CCOBS) that the BC government canceled the foreshore lease for the Deep Water Recovery (DWR) company. This effectively ends DWR's ability to continue operations at their shipbreaking facility in Union Bay. See the CHEK News coverage on July 5th for more details. Over the last year, ADIMS has been supporting CCOBS' efforts to stop the pollution entering Baynes Sound from the DWR site. On Earth Day, we hosted a presentation by CCOBS for Denman residents. We also provided financial support for their legal fees, as well as moral support at rallies. CCOBS continues to advocate for safe and environmentally sustainable shipbreaking by seeking viable regulations for this industry. Hats off to CCOBS and the many Denman residents who have supported their work.
